



Royal Crown Horse Sale Consignor Information

1. All horses must be sired by a Royal Crown Stallion. There will be a \$300 fee due upon consignment. If you sell your horse, the \$300 will be returned. If you don't sell your horse, it will be kept for a no sale fee.
2. Commission Fees are 8% of sale price.
3. No Sale/Pass out fees are \$300. If a horse is pulled from the sale prior to it, there will still be a \$300 pass out fee unless a vet release is supplied explaining why the horse can't sell at the sale along with photos of injury or sickness.
4. Consignments open November 12th, catalog deadline Jan 15. Consignments accepted up to sale day.
5. Registration Papers- All Registration papers will need to be mailed to the office. Transfers must be signed fully including address and accompany the registration papers.

6. Stalls will be \$20/night. All sale horses MUST be checked in Friday, February 19th.
7. Pre Purchase Exam- There will be a vet on site that will go through all horses consigned to the horse sale prior to the sale. If a buyer wants x-rays, he will be available to do x rays and more in depth pre purchase exams.
8. Transport- All horses must have a coggins test current within six months of sale date. All horses coming from a brand state must have a brand inspection. All out of state horses must have current health papers within 30 days.
9. Private sales- There will be absolutely no private sales in the yards before or after the auction. If a horse is "no saled" in the ring but sold outside you are expected to report it to the office.
10. If a horse is "no saled" they will not be eligible for the Royal Crown sale horse sidepot. You have to sell the horse or buy him back at the highest bid price in order for them to be eligible for the sidepot.
11. All horses will be guaranteed as represented in the ring until noon the following day.
12. All checks will be mailed out within 10 business days of the sale.
13. Liability- Buyers, sellers, and spectators are cautioned to exercise care while attending the sale and enter premises at their own risk according to the laws of the State of Texas. Neither the owners nor any other persons connected with this sale assume any liability, legal or otherwise, for accidents to persons or property, before, during, or after the sale.
